The cases brought forward from the preceding year, 2011 were 23 while 41 cases were filed in the reporting year, 2012 totalling 64 cases in all. The disposed cases were 41; 22 Appeals and 19 Motions. 23 cases were still pending due to some unavoidable circumstances emanating from court adjournments, continuation of hearing, non-availability of trial court record of proceedings, etc.

This report contains extra-judicial activities such as the distribution of the estates of the deceased Muslims. This we see as a reflection of the confidence reposed in us by the people.

It is not gainsaying that Sharia is a complete way of life. The contemporary world, as eloquently put "a global village" has brought knowledge and wisdom in all human endeavours and values symbolically closer to the seekers of knowledge and truth. It is therefore desired of a sound mind to always strive to gain more exposure on the unquantifiably endowed gifts of Allah to mankind as represented in this divine law (Sharia).

Assalam Alaykum Warahmatullah,

All praise, adoration and glory be to Allah; the Creator of the heaven and earth, the Cherisher and Sustainer through Whose favour we are all alive today. We thank Him for the unlimited blessings and particularly for His guidance and favour over us. The occasion of today marks one of the greatest event that ever happened to Mankind; the birth of the noblest of all mankind, the leader of the Prophets, the most successful messenger of God who was sent as absolute mercy by God to bring man out of gloomy darkness into brightness of a promising life and divine guidance.

The divine guardian is born, ولد الهدى فالكائنات ضياء
thus the universe was covered
with brightness while new
horizon of hopes expands new
meaning to life.

May the peace and blessings of Allah continue to rain upon the Prophet, His household, his followers and those who follow suit till the Day of Judgment.

I count my humble self as one of the most privileged person to be considered worthy of making a key note address in an occasion such as this where there are eminent personalities, particularly the Mai Martaba, our father, a divinely guided and honoured leader, the custodian of Islam in this part of the country, Sheikh Alimi, Dr. Ibrahim Sulu Gambari, CFR, the Emir of Ilorin and Chairman, Kwara State Traditional Council. Surprisingly, it was a bit difficult for me to aptly capture my thought in choosing an appropriate topic for my short address before this august gathering. This was because a lot had been said in terms of lectures, symposia, preaching, admonitions, and recommendations to move things forward, to shape a new positive direction of improving on the achievements of our fore fathers in the area of unity, love, collective responsibility, mutual understanding, poverty alleviation, youth empowerment, security societal or community development and above all act of devotion to Allah. You will all agree with me that only very little had been achieved in these regards.

However, let me quickly before I forget congratulate the Muslim *ummah* for the unique achievements recorded recently in the commissioning of our new ultra-modern Ilorin Central Mosque and the upgrading of the Historical Palace of the Emir of Ilorin to world standard. The two, without any gainsaying, stand as monumental pride not only to the people of Ilorin but to the entire Nigerians as well as the entire Muslim World. These historical achievements might not have been possible without

the contributions of His Royal Highness, the Emir of Ilorin the late Wazirin Gari, the distinguished sons and daughters of the soil, particularly the Turaki of Ilorin, distinguished senator, Dr. Abubakar Bukola Saraki, *CON*, the former Governor of Kwara State and his successor, the amiable present Governor of the State; Alhaji AbdulFatah Ahmed and other respected contributors. God knows them all and shall reward them abundantly.

May I use this opportunity which I count as a great honour for me and the institution I am representing to highlight some issues that crossed my humble mind when I saw the invitation as follows:

1. That the occasion of today calls for a very sober reflection beyond mere celebration on the current situations which the Muslims both internally and externally are facing today; they are not at all easy. They are loaded with threatening challenges and uphills wraped in a shroud of ignorance for what the future holds for us and our religion. There are serious strategic plans and conspiracies from many angles to fight Islam and its followers. Muslims are called series of bad names such as extremists, fanatics and terrorist. All kinds of campaign are geared towards putting an end to the noble mission of Allah.

They want to extinguish Allâh's Light (with which Muhammad الله الله))

(peace be upon him) has been sent - Islâmic Monotheism) with their mouths, but Allâh will not allow except that His Light should be perfected even though the Kâfirûn (disbelievers) hate (it).

بأفواههم ويأبى الله إلا أن يتم نوره ولو كره الكافرون))

2. Servants of Allah, we should use the above to reflect on the current situation in the Muslim world particularly out great country. Islam is surrounded by various problems from all directions. Some of these problems are external while the major ones are within. We no longer see or perceive ourselves as *ummah*, a single community of faithful whose goals and aspirations, objectives and desires are one. Our divine duty to mankind sterling qualities as admonishers of belief in Allah and righteousness to humanity are declining. Our brotherhood is no longer felt while our roles and contributions to peace, harmony, unity and co-existence are questionable. Most astonishing is the degree by which our faith in God, our steadfastness and endurance are fading away. Where are we heading towards?

Most of us, particularly our youths are seriously deviating, they are indulged in hooliganism, thugry cultism and robbery and other mischievous acts. Morality and good character are almost buried! Why did we allow ourselves to be so vulnerable as if we are mere tools in the hands of politicians just because of love of materials? I think it is high time we call ourselves to order and return back to Islam before we are caught up by Allah's wrath.

3. These thoughts call my humble attention to the prophecy of the Prophet some hundred years ago when he received the revelation of Surah Al-An'am; verse 6 which reads as follows:

Say, "He is the [one] Able to send upon you affliction from above you or from beneath your feet or to confuse you [so you become] sects and make you taste the violence of one another." Look how We diversify the signs that they might understand.

" قُلْ هُوَ الْقَادِرُ عَلَىٰ أَن يَبْعَثَ عَلَيْكُمْ عَذَاباً مِّن فَوْقِكُمْ أَوْ مِن تَحْتِ أَرْجُلِكُمْ أَوْ مِن تَحْتِ أَرْجُلِكُمْ أَوْ مِن تَحْتِ أَرْجُلِكُمْ أَوْ يَلْمِسَكُمْ شِيَعاً وَيُلْدِيقَ بَعْضَكُم بَأْسَ بَعْضٍ أَ انظُرْ كَيْفَ نُصَرِّفُ الْآيَاتِ لَعَلَّهُمْ يَفْقَهُونَ "

When the noble Prophet received this verse, he performed an ablution and observed two (2) rakahs, then calm himself soberly in protration and prayed to Allah out of fear from the contents of the verse. He asked for three things out of which two were granted and one was rejected. He asked that his *ummah* should not be destroyed by drought and famine; and should not be destroyed by external enemies. These two were

granted by Allah. The third prayer that was not granted was that the *ummah* should not rise against one another and face persecution from amongst themselves.

The Prophet thereafter said the following hadith which summarily gave the vivid picture of the problems the entire Muslim *Ummah* are encountering today:

Narrated bv eminent two disciples; Thawban, the aid to the Prophet and Abu Hurairah: the Prophet said: 'Imminently, there will come a time when the nations will gather against you, just as people gather around a feast.' A man said. 'Will it be because we are few at that time, O Allah's Messenger?' He responded, 'No, you will be numerous in those times, but you will be as useless as the scum of the sea, and Allah will remove your respect and fear from the heart of your enemies, and He will put al-Wahn into vour hearts', then they asked: 'What is al-Wahn?'. he responded. 'Love of life. and hatred of death."

In the light of the above, it is obvious that our problems emanated from our non-compliance with the teachings of Islam.

Obedient servants of Allah, the only solution to our problems is to return to Allah, to re-actualize ourselves, to account for our deeds and reshape our lives in line with the righteous teachings of Islam. We should not sacrifice the hereafter for this material world neither should we sacrifice our future for the present. We should live a life that reflects the injunction of the Qur'an which says:

You are the best of peoples ever الناس تأمرون raised up for mankind; you enjoin righteousness and forbid evil, and you belief in Allah.

May I round up my humble address by calling your attention once again to the following verse by which Allah enjoined us to emulate and take the Prophet as a reflective mirror of our lives:

Indeed, in the Messenger of Allah الله أسوة (Muhammad) you have a good example to follow for him who hopes for (the meeting with) Allah and the Last Day, and remembers Allah much

May I once again humbly appeal to our Muslim *ummah* to let their attitude to life reflect the undisputable exemplary and pious lifestyle of the Prophet. We pray Almighty Allah (SWT)

to guide us to the straight path of those upon whom He bestowed His favour and not those who had gone astray, amin.
